Covered Device Recycling Act (CDRA)



- Landfill ban in effect since Jan. 24, 2013
- Covered devices can no longer be put in the trash
- Impacts electronic devices for consumer households and businesses less than 50 employees

Covered Device Recycling Act

Covered devices include:

- Desktop and laptop computers
- Monitors
- Computer peripherals
- Televisions
- E-readers that browse the internet

Covered Device Recycling Act

Covered devices DO NOT include:

- Kitchen appliances (toaster oven, microwave, blender, etc.)
- Bathroom appliances (blow dryer, curling iron, electric razor, etc.)
- Cell phones, pagers and cameras

* Although these devices do not fall under CDRA, they might still be recycled depending upon the collection event.

Covered Device Recycling Act

The CDRA involves participation from:

- Manufacturers
- Retailers
- Collectors of covered devices
- Waste haulers
- Recycling facilities
- DEP
- Local Governments
- Households

Covered Device Recycling Act

How can consumers recycle their covered devices?

- Retailers may only sell brands that are registered with DEP and will notify their consumers how to recycle covered devices
- No cost to consumers for recycling covered devices through a manufacturer's program
- Many locations will accept covered devices, but always best to call first

Covered Device Recycling Act

Examples of facilities that may take covered devices:

- Large retailers (big box stores)
- Thrift stores
- Community E-Scrap collection events
- County E-Scrap collection events
- Permitted E-Scrap Recyclers

Note: It is always best to call a specific location before taking electronics there for recycling. Some locations may not accept Cathode Ray Tube TVs and monitors or may charge to drop off electronics

▶ Household Hazardous Waste (HHW)

- Household Hazardous Wastes are those wastes produced in our households that are hazardous in nature, but are not regulated as hazardous waste, under federal and state laws
- Each person in Pennsylvania produces an average of four pounds of HHW each year or about 25,000 tons per year statewide

Household Hazardous Waste

- HHW are items, such as:

- Old paints and paint related products
- Pesticides
- Pool chemicals
- Drain cleaners
- Degreasers and other car care products



- Such consumer waste products, if carelessly managed can create environmental and public health hazards

Household Hazardous Waste

What can you do about HHW?

- Avoid creating it
- Select least toxic product, buy only what is needed.
- Give it away! A friend, neighbor, or community group such as Habitat for Humanity may be able to use it.
- Check with your County Recycling Coordinator to determine if your community has HHW collection program.

Household Hazardous Waste

- Used motor oil and used oil filters need to be recycled at a used oil collection site.
- There is more information about collection sites available on DEP's website.
- Take spent lead acid batteries back to where you bought them.
- State law requires dealers to accept old batteries when you buy new ones

Household Hazardous Waste

HHW may be disposed in your regular trash PROVIDED:

- You have complied with any disposal instructions on the label.
- There are no free-standing liquids; if water based, allow the liquid to evaporate, if not water-based, absorb the liquid into vermiculite, cat litter, saw dust or other absorbent material

Household Hazardous Waste

HHW may be disposed in your regular trash PROVIDED:

- You have carefully packaged any residue to prevent leakage while the material is being transported to a disposal facility.
- You have only a small quantity. Divide larger quantities and dispose of them over several collection periods

Household Hazardous Waste

- DEP posts HHW Collection Events on the website for residents to recycle their items.

If your group is looking to participate in the effort to keep Pennsylvania litter-free and beautiful, earning community service credits or simply wanting to get involved as dedicated, civic-minded individuals, read on! You'll be joining a **Highway Beautification Programs** Pennsylvania's collective front yard – its 150,000 acres of roadside.

PennDOT offers a wide variety of beautification programs in a concerted effort to reduce the costs of removing unsightly litter from Pennsylvania's roadways:

Adopt-A-Highway – Volunteers beautify roadsides two miles at a time. You or your civic or volunteer group sign a two-year program participation request to pick up litter at least four times a year. In return, PennDOT posts signs along the highway giving you or your group full credit for your efforts.

Adopt and Beautify – Volunteers expand upon PennDOT's planting efforts

Register An Event



After you register your event, it will be listed among all of the events in Pennsylvania, and will be searchable by anyone wishing to participate.

Please allow three to five business days for your event to be posted and for your confirmation email, which will notify you that your event application has been processed and will include your event registration/ID number.
